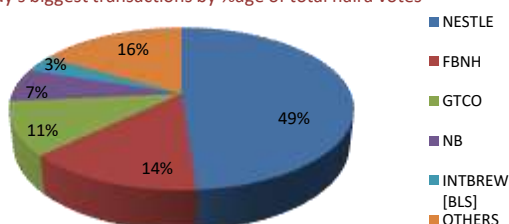
Nigerian Equities Market Reverses Gain as All-Share Index Falls by 0.22%; OTC Bonds Market Trades Quietly ahead of Today's Auction Results...

The local equities market index declined by 0.22% to close at 43,349.90 points amid renewed profit taking activity as short-term traders dominate the local bourse in search of quick profit. Hence, the year-to-date gain of the local bourse moderated to 7.65%. The Exchange recorded a higher number of losers (24) than gainers (14). We witnessed profit taking on symbols such as UNILEVER, ARDOVA, GTCO, FLOURMILL and ACCESS as their respective share prices moderated by 7.53%, 5.38%, 2.23%, 1.32% and 2.67. Performance across sub-indices tracked was relatively weak as four out of five sub-indices tracked closed south. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/ Gas indices decreased by 0.37%, 0.85%, 0.66% and 0.82% respectively. However, the NSE Industrial index rose by 0.01%. Meanwhile market activity mellowed as the volume and value of stocks traded melted by 37.53% and 47.77% to 264.79 million and N6.08 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid renewed financial system liquidity boost. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked ahead of auction results. On the flip side, the value of FGN Eurobond decreased for all maturities tracked amid sustained sell sentiment.
