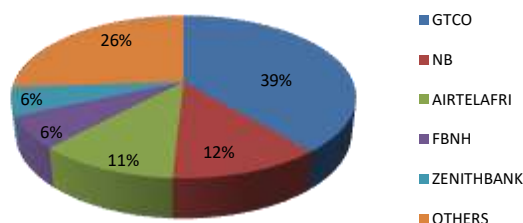
## Domestic Equities Market Index Falls by 0.20% amid Sustained Profit Taking Activity; NIBOR Moderates for Most Tenor Buckets Tracked on Liquidity Ease...

The Nigerian stock exchange index decreased further by 0.20% to close at 43,199.27 points as investors continued to take profit to close for the weekend. Hence, the year-to-date gain of the local bourse fell to 7.27%. Also, the Exchange printed higher number of losers (23) than gainers (16). Notably, investors took profit on symbols such as NGXGROUP, NB, GTCO, ETERNA and FLOURMILL, hence their respective share prices moderated by 8.86%, 2.86%, 2.68%, 9.03% and 1.85%. Performance across sub-indices tracked was bearish as all of the five sub-sector gauges tracked closed in red. The NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/ Gas and the NSE Industrial indices plummeted by 0.79%, 0.66%, 0.57%, 0.23% and 0.01% respectively. Meanwhile market transaction was mixed as the volume stocks traded decreased by 5.24% to N199.52 million while the value of stocks traded rose by 24.93% to N3.26 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed financial system liquidity boost. Also, NITTY moderated for most maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked. On the flip side, the value of FGN Eurobond moderated for all maturities tracked amid sustained bearish sentiment.
