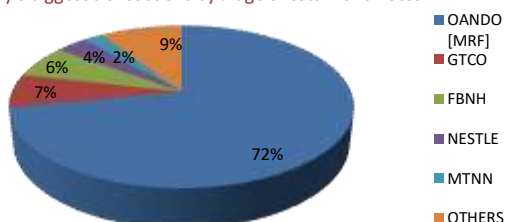
NSE ASI Rebounds by 0.14% as Oando Shares Account for 72% of Total Value Traded; NIBOR Moves in Mixed Directions as Banks Reduces Overnight Borrowings...

The Nigerian stock exchange All Share-Index rebounded by 0.14% to close at 43,260.13 points following three consecutive days of losses. Hence, the year-to-date gain of the local bourse increased to 7.42% even as the Exchange printed higher number of gainers (18) than losers (16). We saw buying interest in Tickers such as Oando, NESTLE, FBNH, CONOIL, ZENITHBANK and HONYFLOUR. Notably, the acquisition of over 70% of HONYFLOUR shares by FLOURMIL lifted its share price by 9.73% to 3.72%. Performance across sub-indices tracked were largely positive as four of the five sub-sector gauges tracked closed in green. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices rose by 0.76%, 0.86%, 0.01% and 1.27% respectively. However, the NSE Industrial fell by 0.14%. Meanwhile market transactions ballooned today chiefly on N11.83 billion worth of trading value on Oando shares. Hence, the volume and value of stocks traded rocketed by 1,103.94% and 405.72% to N2.40 billion and N16.47 billion respectively. Elsewhere, NIBOR moved in mixed directions. However, NITTY moderated for most maturities tracked as traders get set for auction this week. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond moderated for all maturities tracked amid sustained bearish sentiment.
