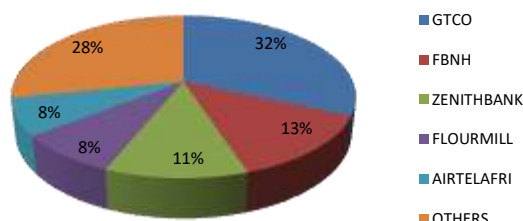
Nigerian Stock Market Trades Sideways as MPC Retains Policy Rate at 11.50% Today; NITTY Rises for Most Maturities ahead of Primary Auction Tomorrow...

The Nigerian equities market All Share-Index fell marginally by 0.01% to close at 43,255.14 points as the Monetary Policy Committee (MPC) retained Policy Rate at 11.50% in order to further boost economic growth given the recently printed 4.03% growth in GDP. Hence, the year-to-date gain of the local bourse fell to 7.41% albeit the Exchange printed higher number of gainers (19) than losers (15). Performance across sub-indices tracked was relatively weak as three of the five sub-sector gauges tracked closed in red territory. The NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices moderated by 1.97%, 0.16% and 0.20% respectively. However, the NSE Banking index rose by 0.21% while the NSE Industrial index was flattish. Meanwhile market activity came in weak today as the volume and value of stocks traded decreased by 90.93% and 82.34% to N217.97 million and N2.91 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid financial system liquidity squeeze. However, NITTY increased for most maturities tracked ahead of primary auction tomorrow. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond moderated for all maturities tracked amid sustained bearish activity.
