Nigerian Equities Market Falls by 0.02% amid Sustained Sell-Pressure; 364-day T-bills Rate Moderates to 5.89% amid Huge Subscription...

The Nigerian equities market All Share-Index fell further by 0.02% to close at 43,245.02 points amid sustained profit taking activity. Specifically, investors took profit on tickers such as STANBIC, ETERNA, HONYFLOUR, FBNH and UCAP. Hence, their respective share prices moderated by 3.21%, 9.02%, 9.78%, 2.44% and 1.53% even as the year-to-date gain of the local bourse plunged to 7.39% despite the Exchange printing higher number of gainers (23) than losers (18). Nevertheless, performance across sub-indices tracked was largely positive except for the NSE Oil/Gas index which fell by 0.24%. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices increased by 0.25%, 2.05%, 0.09% and 0.13% respectively. Meanwhile market activity came in strong today as the volume and value of stocks traded increased by 11.57% and 28.86% to N243.19 million and N3.75 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid financial system liquidity ease. However, NITTY increased for most maturities tracked despite the declining rate for 364-day Tbills. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked. On the positive side, the value of FGN Eurobond increased for all maturities tracked amid renewed bullish activity even as Naira appreciated against other foreign currencies.
