Local Bourse Index Declines by 0.32% as Seplat, NB Shares Shed Value; NIBOR Moderates for Most Tenor Buckets amid Liquidity Ease...

The Nigerian stock exchange All Share-Index nosedived by 0.32% to close at 43,108.77 points amid sustained bearish sentiment. Notably, investors took profit on high-cap stocks such as SEPLAT, NB, MRS, ETI and UACN. Hence, their respective share prices plummeted by 3.63%, 5.14%, 9.87%, 8.57% and 4.31% even as the year-to-date gain of the local bourse fell to 7.05%. Also, the Exchange printed higher number of losers (24) than gainers (14). Given the profit taking activity, most of the sub-indices tracked closed in red territory as the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices decreased by 1.16%, 1.06%, 1.64% and 0.01% respectively. Meanwhile market transactions still closed higher despite the weak benchmark index performance. The volume and value of stocks traded increased by 9.43% and 12.54% to N266.12 million and N4.22 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid sustained financial system liquidity ease. Also, NITTY fell for all maturities tracked in line with the declining rate for 364-day T-bills. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked. On the positive side, the value of FGN Eurobond increased for all maturities tracked amid sustained bullish activity.




