Local Bourse Index Rebounds by 0.46% amid Renewed Bullish Activity; NIBOR Moderates for Most Tenor Buckets amid Sustained Liquidity Ease...


The Nigerian equities market All Share-Index rebounded by 0.46% to close at 43,308.29 points amid renewed bargain hunting activity. We saw buying interest in tickers such as AIRTELAFRI, ARDOVA, UPL, GUINNESS and AIICO as their respective share prices increased by 3.83%, 3.03%, 8.89%, 0.27% and 9.37%. Consequently, the year-to-date gain of the local bourse bounced back to 7.54% albeit, the Exchange printed a higher number of losers (24) than gainers (18). Despite the rise in the benchmark index, most of the sub-indices tracked closed in red territory as the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices decreased by 0.33%, 0.89%, 0.03% and 0.01% respectively. However, the NSE Insurance index rose by 1.98%. Meanwhile market activity was mixed bag as the volume of stocks traded increased by 14.73% to N305.32 million while the value of stocks traded decreased by 15.15% to N3.58 billion. Elsewhere, NIBOR fell for all tenor buckets amid sustained financial system liquidity ease. However, NITTY rose for most maturities tracked amid bearish sentiment. In the OTC bonds market, the values of FGN bonds was flattish for all maturities tracked. On the flip side, the value of FGN Eurobond fell for all maturities tracked amid renewed bearish activity.
