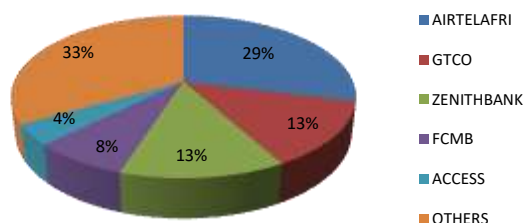
Local Bourse Index Moderates by 0.09% amid Renewed Bearish Activity; NIBOR Stays Flat across all Tenor Buckets...

The Nigerian stock market All Share-Index moderated by 0.09% to close at 43,270.94 points amid renewed profit taking activity. We saw sell-pressure on tickers such as UPDC, UPDCREIT, CHIPLC, REGALINS and INTBREW as their respective share prices decreased by 9.92%, 9.90%, 7.27%, 4.76% and 4.00%. Consequently, the year-to-date gain of the local bourse bounced back to 7.45% even as the Exchange printed a higher number of losers (21) than gainers (14). Given the decline in the benchmark index, most of the sub-indices tracked closed in red territory as the NSE Banking, NSE Consumer Goods and the NSE Oil/Gas indices decreased by 0.18%, 0.23% and 0.56% respectively. However, the NSE Insurance index rose by 0.82% while the NSE Industrial index closed flat. Meanwhile market activity was weak as the volume and value of stocks traded fell by 30.20% and 34.05% to N213.13 million and N2.36 billion. Elsewhere, NIBOR was flattish for all tenor buckets. However, NITTY rose for all maturities tracked amid sustained bearish sentiment. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked amid renewed bullish activity. Also, the value of FGN Eurobond rose for most maturities tracked amid renewed buy pressure.
