
Nigerian Stock Exchange Index Further Declines by 0.05% amid Sustained Sell-Pressure; NIBOR Rises for all Tenor Buckets on Renewed Liquidity Squeeze... The local equities market All Share-Index (ASI) further decreased by 0.05% to close at 43,248.05 points amid sustained profit taking activity. Notably, there was sustained sell-pressure on UPDCREIT and UPDC as their share prices collapsed by 9.89% and 9.32% respectively. Other tickers on the bottom losers were IKEJAHOTEL, CHAMS and UBN shares. Consequently, the year-to-date gain of the local bourse bounced back to 7.39% even as the Exchange printed 24 losers as against 12 gainers. Given the moderation in the benchmark index, most of the sub-indices tracked closed in red territory as the NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices decreased by 0.21%, 0.40% and 0.04% respectively. However, the NSE Banking index and the NSE Insurance index rose by 0.26% and 1.64% respectively. Meanwhile market activity was upbeat as the volume and value of stocks traded increased by 5.53% and 57.16% to N224.91 million and N3.71 billion. Elsewhere, NIBOR rose for all tenor buckets amid renewed financial squeeze. However, NITTY moved in mixed bag across maturities tracked. In the OTC bonds market, the values of FGN bonds was flattish for all maturities tracked. Also, the value of FGN Eurobond moderated for all maturities tracked amid renewed sell pressure.
