

The domestic stock market All Share-Index (ASI) plummeted by 1.81% to close at 42,463.16 points as MTNN share price tumbled by 10% to close at N171/share. Also, investor's negative sentiment on UPDC persisted today, leading to another 7.48% weight loss on the share price of the property development company. Other stocks on the bottom losers include AFRIPRUD, ROYALEX and HONYFLOUR shares. Hence, the year-to-date gain of the local bourse bled to 5.44% even as the Exchange maintained a higher number of losers (23) than gainers (15). Amid bearish sentiment, the NSE Banking index, NSE Consumer Goods index and the NSE Oil/Gas index decreased by 1.15%, 0.14% and 0.12% respectively. However, the NSE Industrial index the NSE Insurance index rose by 0.04% and 0.77% respectively. Meanwhile market activity bled today as the value of stocks traded decreased by 4.20% to N3.55 billion. However, the volume of stock traded rose by 49.16% to N335.48 million amid recorded N133.99 million units of FBNH shares that exchanged hands today. Elsewhere, NIBOR fell for most tenor buckets on renewed financial ease. Also, NITTY fell for most maturities tracked on demand pressure. In the OTC bonds market, the values of FGN bonds was flattish for all maturities tracked. However, the value of FGN Eurobond rose for most maturities tracked.
