Nigerian Equities Market Index falls by 0.51% amid Sustained Sell-Pressure; NIBOR Moderates for most Tenor Buckets on Renewed Liquidity Boost...

The Nigerian equities market All Share-Index (ASI) fell by 0.51% to close at 42,247.98 points amid sustained profit taking activity. Also, investor's negative sentiment on UPDC persisted today, leading to another 9.09% weight loss on the share price of the property development company. Specifically, investors took Profit on tickers such as AIICO, MANSARD, SEPLAT, GLAXOSMITH. Hence, their respective share prices moderated by 7.32%, 7.89%, 6.47% and 6.30% as the Exchange saw a higher number of losers (34) than gainers (17). Amid bearish sentiment, the NSE Banking index, NSE Insurance index, the NSE Oil/Gas index and the NSE Industrial index decreased by 1.18%, 2.24%, 3.51% and 0.10% respectively. However, the NSE Consumer index rose by 0.08%. Meanwhile market activity rose today as the value of stocks traded increased by 49.02% to N5.29 billion; albeit, the volume of stock traded fell by 0.51% to N324.02 million as investors traded more of high cap stocks. Elsewhere, NIBOR fell for most tenor buckets on renewed financial liquidity ease. Also, NITTY fell for most maturities tracked on demand pressure. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked. Also, the value of FGN Eurobond rose for most maturities tracked on sustained buy pressure.




