NGX All-Share Index Falls further by 0.19% amid Sustained Sell-Pressure; NIBOR Falls for All Tenor Buckets amid Financial System Liquidity Ease...

The domestic stock market index plummeted by 0.19% to close at 42,247.98 as the bears finally took over the Exchange. Hence, the year-to-date gain of the local bourse fell to 4.71%. Also, the Exchange printed a higher number of losers (18) than gainers (13). Specifically, the share prices of COURTVILLE, UNITYBANK, HONEYFLOUR, AIICO and FBNH declined by 5.13%, 3.77%, 2.78%, 2.63% and 2.07% respectively. Performance was mixed bag across subindices, while the NGX Industrial index and NGX Insurance index rose by 0.02 and 2.0% respectively, the NGX Banking index and the NGX Consumer Goods index decreased by 0.06%, 0.09% respectively. However, the NGX Oil/Gas index closed flat. Meanwhile market activity nosedived today as the value of stocks traded decreased by 54.19% to N2.43 billion; also, the volume of stock traded fell by 44.15% to N180.95 million as investors sold more of high cap stocks. Elsewhere, NIBOR fell for all tenor buckets tracked on renewed financial liquidity ease. Also, NITTY fell for most maturities tracked on demand pressure. In the OTC bonds market, the values of most FGN bonds rose for maturities tracked amid renewed buy pressure. Also, the value of FGN Eurobond rose for all maturities tracked on sustained buy pressure.
