

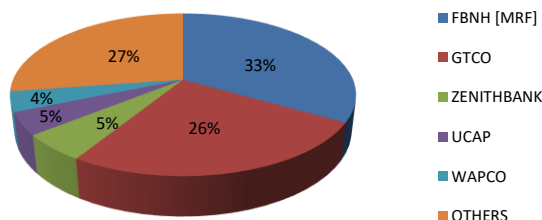


Nigerian Stock Market Index Plunges by 0.38% amid Sell-offs on WAPCO, LINKASSURE Shares; NIBOR Rises for most Maturities Tracked on Renewed Liquidity Squeeze...

The local bourse index plunged by 0.38% to close at 42,008.60 points amid sell-offs on shares of WAPCO, LINKASSURE, VITAFOAM and ABCTTRANS. Hence, their respective share prices fell by 9.94%, 8.93%, 8.685 AND 8.82% respectively. Consequently, the year-to-date gain of the local bourse fell to 4.315%. Also, the Exchange printed a higher number of losers (25) than gainers (8). On a bullish note, we saw major gains on UPDC, MEYER JAIZBANK leading to a 9.09%, 9.09% and 4.69% gains on their respective share prices. Given the bearish sentiment, the NGX Industrial index, NGX Insurance Index, the NGX Banking index, the NGX Consumer Goods index and the NGX Oil/Gas index fell by 0.58%, 1.77%, 1.37%, 0.34 and 0.11% respectively. Meanwhile market activity rose today as the value of stocks traded increased by 84.34% to N4.47 billion; also, the volume of stock traded rose by 133.31% to N422.18million as investors traded more of high cap stocks. Elsewhere, NIBOR rose for most maturities tracked amid renewed financial system liquidity squeeze: While NITTY saw mixed movements. In the OTC bonds market, the values of the FGN bonds moved in mixed directions across maturities tracked. On the flip side, the value of FGN Eurobond moderated for most maturities tracked amid sustained bullish sentiment.
