NGX Index Rebounds by 0.14% amid Gains on NEM, WAPCO, and ZENITHBANK Shares; NIBOR Falls for most Maturities Tracked on Renewed Liquidity Ease... The Nigerian stock exchange All Share-Index rebounded by 0.02% to close at 42018.92 points following three consecutive days of losses. Hence, the year-todate gain of the local bourse increased to 4.341% as the Exchange printed a higher number of gainers (20) than losers (19). We saw buying interest in Tickers such as NEM, WAPCO, COURTVILLE, ZENITHBANK, ETI, FIDELITYBK and GTCO. Given the bullish sentiment, Performance across sub-indices tracked were largely positive as four of the five sub-sector gauges tracked closed in green. The NGX Industrial index, NGX Insurance Index, the NGX Banking index and the NGX Consumer Goods index rose by 0.29%, 1.14%, 1.13% and 0.11% respectively. However, the NGX Oil/Gas index fell by 2.70%. Meanwhile market activity ballooned today chiefly on N4.11 billion worth of trading value on FBNH shares. Hence the value and volume of stocks traded increased by 48.23% and 51.46% to N6.63 billion and N639.44million respectively, as investors traded more of Blue-Chip stocks. Elsewhere, NIBOR moderated for most maturities tracked amid renewed financial system liquidity Ease: While NITTY saw mixed movements. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond moderated for most maturities tracked amid continued bullish sentiment.
