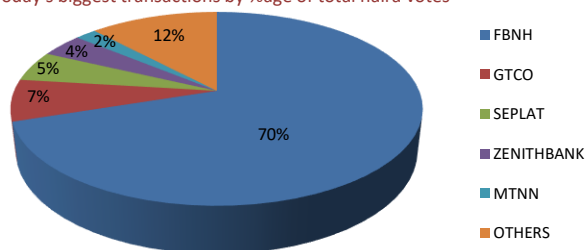


Local Bourse Index Soars by 0.99% amid Sustained Bullish Activity; NIBOR Rises for all Tenor Buckets Tracked on Liquidity Squeeze...

The Nigerian equities market All Share-Index soared by 0.99% to close at 42435.16 amid sustained bargain hunting activity. We saw buying interest in tickers such as MANSARD, DANGSUGAR, UBA, MTNN AND ETI as their respective share prices increased by 7.25%, 6.68%, 5.30%, 4.49% and 4.29%. Consequently, the year-to-date gain of the local bourse bounced back to 5.38% as the Exchange saw consecutive days of higher number of gainers (20) than losers (11). Given the bullish sentiment, Performance across sub-indices tracked were positive as all of the five sub-sector gauges tracked closed in green. The NGX Industrial index, NGX Insurance Index, the NGX Banking index, NGX Oil/Gas and the NGX Consumer Goods index, rose by 0.10%, 0.62%, 1.83%, 1.14% and 0.41% respectively. Elsewhere, market activity was positive today as investors traded more of Blue-chip stocks today. Hence, the value and volume of stocks traded rose by 8.71% and 1.61% to N7.20 billion and N649.77million respectively. Elsewhere, NIBOR rose for all tenor buckets tracked amid financial system liquidity squeeze: While NITTY fell for most maturities tracked amid bearish sentiment. In the OTC bonds market, the values of the FGN bonds moved in mixed directions across maturities tracked. On the flip side, the value of FGN Eurobond moderated for most maturities tracked amid continued bullish sentiment.
