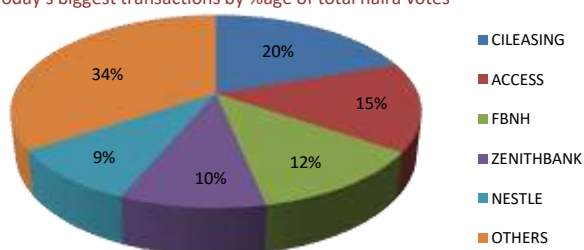

Local Bourse Index rises by 0.47% amid Gains on MEYER, GUINNESS and Banking Shares; NIBOR Stays Flat across All Tenor Buckets...

The domestic stock market index rose by 0.47% to close at 41,882.97 points amid renewed bargain hunting activity as we saw buying interest in tickers such as MEYER, GUINNESS, FIDELITYBK, ETI and GTCO. Hence, their respective share prices increased by 10.00%, 6.85%, 4.53%, 4.02% and 3.92%. Consequently, the year-to-date gain of the local bourse rose to 4.00%. The Exchange printed a higher number of gainers (24) than losers (13) even as investors reshuffled their holdings to position in banking shares. Given the bullish sentiment, Performance across sub-indices tracked were positive, leading to northward movement in all the five sub-sector gauges tracked. The NGX Insurance Index, the NGX Banking index, the NGX Oil/Gas, the NGX Industrial index and the NGX Consumer Goods index, moderated by 0.16%, 2.20%, 1.30%, 0.11% and 0.24% respectively. Elsewhere, market activity was weak today as the value and volume of stocks traded decreased by 33.85% and 6.03% to N3.42 billion and N444.94million respectively. Elsewhere, NIBOR was flattish for all tenor buckets tracked. However, NITTY fell for all maturities tracked amid sustained bullish sentiment. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond moderated for all maturities tracked amid sustained sell pressure.
