

NGX All-Share Index Rises further by 1.26% amid sustained Bullish Sentiment; NIBOR Falls for most Maturities Tracked on Financial System Liquidity Boost...

The Nigerian equities market All-Share Index rose by 1.26% to close at 42,411.12 points amid sustained bargain hunting activity. We saw buying interest in tickers such as MEYER, GLAXOSMITH, MTNN, AIICO and HONEYFLOUR as their respective share prices surged by 9.09%, 7.08%, 7.05%, 2.94% and 2.78%. Hence, the year-to-date gain of the local bourse rose to 5.32%. Given the bullish sentiment, the Exchange printed a higher number of gainers (23) than losers (16). Nevertheless, performance across sub-indices tracked were largely negative except for the NGX Industrial which rose by 0.66%. The NGX Insurance Index, the NGX Banking index, the NGX Oil/Gas and the NGX Consumer Goods index, decreased by 0.15%, 0.47%, 0.96% and 0.05% respectively. Elsewhere, market activity slumped today as the value and volume of stocks traded further decreased by 48.39% and 3.92% to N3.29 billion and N229.64million respectively. Elsewhere, NIBOR fell for most tenor buckets tracked amid financial system liquidity boost. However, NITTY moved in mixed direction. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond moved in mixed direction.
