Local Bourse Index Falls by 0.22% amid Profit Taking Activities on Banking Shares; NIBOR Stays Flat across all Tenor Buckets...

The domestic stock market plummeted by 0.22% to close at 42,317.52 points as the bears finally took over the Exchange. Hence the year-to-date gain of the local bourse fell to 5.08%. Also, the Exchange printed a higher number of losers (18) than Gainers (13). Specifically, the share prices of UPDCREIT, GTCO, ETI, PZ, STANBIC and UBA declined by 6.68%, 3.85%, 2.69%, 1.67%, 1.37% and 1.25% respectively. Given the bearish sentiment, performance across sub-indices tracked were largely negative except for the NGX Insurance and NGX Consumer Goods index which rose by 0.35% and 0.08% respectively. The NGX Banking index, the NGX Oil/Gas and the NGX Industrial index, decreased by 1.11%, 0.08% and 0.05% respectively. However, market activity was mixed bag as the volume of stocks traded today increased by 17.62% to N270.09 million while the value of stocks traded decreased by 30.09% to N2.30 billion. Elsewhere, NIBOR was flattish for all tenor buckets. However, NITTY fell for all maturities tracked amid renewed bullish sentiment. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond fell for all maturities tracked amid renewed bearish activity.
