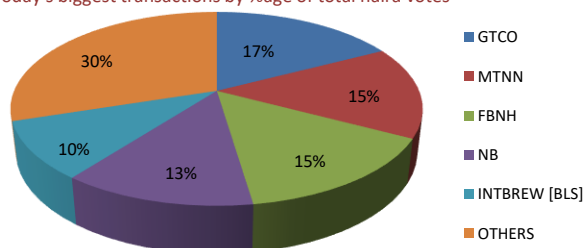

Nigerian Stock Market Index Rebounds by 0.09% amid Gains on MEYER, FCMB, DANSUGAR, GTCO Shares; NITTY Falls for Most Maturities Tracked amid Buy Pressure...

The Local bourse Index rebounded by 0.09% with a gain of 5.18% year-to-date to close at 42,357.35 points, even as the Exchange printed a higher number of Gainers (19) than Losers (13). MEYER (+7.69%), FCMB (+3.45%), DANSUGAR (+2.82%) and GTCO (+2.40%) closed positive while ETRANZACT (-9.57%), UNITYBNK (-2.13%), TRANSCORP (-2.06%) and UACN (-2.04%) closed negative. However, performance across sub-indices tracked were largely negative except for the NGX Insurance Index and the NGX Consumer Goods index which rose by 0.08% and 0.22% respectively. The NGX Banking index, NGX Oil/Gas Index and the NGX Industrial index, decreased by 0.20%, 0.05% and 0.11% respectively. Meanwhile, market activity was mixed bag as the volume of stocks traded today decreased by 16.26% to N226.18 million while the value of stocks traded increased by 14.50% to N2.63 billion. Elsewhere, NIBOR moved in mixed directions for all maturities tracked. However, NITTY fell for all maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond dipped for all maturities tracked amid sustained bearish activity.
