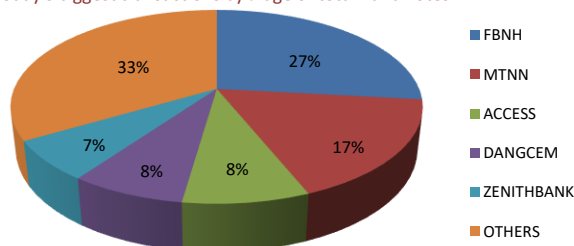

NGX All-Share Index dips by 0.21% amid Renewed Sell-Pressure; NIBOR stays Flat for Most Tenor Buckets Tracked...

The domestic stock market dipped by 0.21% to close at 42,270.23 points amid renewed profit taking activities. Hence, the year-to-date gain of the local bourse fell to 4.97%. Market Sentiment was negative as the Exchange printed a higher number of losers (20) than gainers (15). Specifically, the share prices of CAP (-5.70%), CUTIX (-4.00%), WEMABANK (-3.75%), AIICO (-2.86%) and HONEYFLOUR (-1.87%) closed negative while ROYALEX (+5.00%), ETI (+3.26%), TRANSCORP (+3.16%), COURTVILLE (+2.70%) and TOTAL (+2.35%) closed positive. However, performance across sub-indices tracked were largely positive except for the NGX Insurance Index and the NGX Industrial index which fell by 0.83% and 0.73% respectively. The NGX Banking index, NGX Oil/Gas Index and the NGX Consumer Goods index, Increased by 0.45%, 0.54% and 0.11% respectively. Meanwhile, market activity improved as the value and volume of stocks traded today increased by 35.73% to N3.57 billion and 10.28% to N249.43 million. Elsewhere, NIBOR was flattish for most tenor buckets tracked. However, NITTY fell for all maturities tracked amid sustained buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish for all maturities tracked. Also, the value of FGN Eurobond remained unchanged for all maturities tracked.
