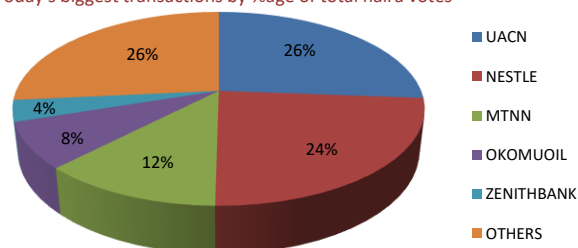

NGX All-Share Index Falls Further by 0.34% amid Sustained Sell-Pressure; NIBOR Rises for All Tenor Buckets amid Financial System Liquidity Squeeze...

The domestic stock market index plummeted by 0.34% to close at 42,244.22 points amid sustained sell pressure. Hence, the year-to-date gain of the local bourse fell to 4.90%. Also, the Exchange printed a higher number of losers (18) than gainers (15). Specifically, the share prices of ETERNA, MRS, FCMB, OANDO and WAPCO declined by 9.91%, 9.85%, 4.33%, 3.96% and 3.75% respectively. Elsewhere, three of the five sub-sector gauges tracked closed in the red territory. The NGX Banking index, NGX Industrial Index and the NGX Oil/Gas index, decreased by 1.00%, 0.21% and 0.75% respectively, while the NGX Insurance Index and the NGX Consumer Goods index rose by 0.55% and 0.58% respectively. Elsewhere, market activity was weak as the volume and the value of stocks traded today decreased by 18.87% and 32.47% to N224.03 million and N 2.66 billion respectively. Elsewhere, NIBOR rises for all tenor buckets tracked on renewed financial liquidity squeeze. However, NITTY fell for all maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond moderated for most maturities tracked amid sustained bearish sentiment.
