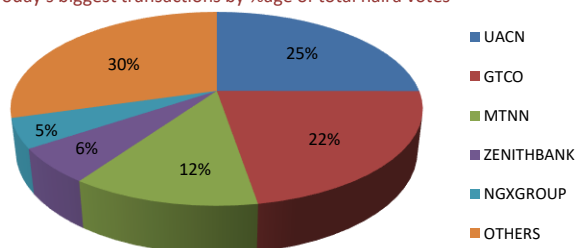

**Nigerian Stock Market Index Further Falls by 0.03% amid Losses on JBERGER, UPDC, FBNH Shares; NIBOR stays Flat across Tenor Buckets....**

The Local bourse Index further fell by 0.03% to close at 42,230.48 points, despite the Exchange printing a higher number of gainers (14) than losers (11). Consequently, the year-to-date gain of the local bourse fell to 4.87%. JBERGER (-9.88%), UPDC (-5.60%), FBNH (-2.50%) and HONEYFLOUR (-1.43%) closed negative; while UBN (+9.78%), ETERNA (+6.67%), OANDO (+5.26%) and FCMB (+4.53%) closed positive. Nevertheless, performance across sub-indices tracked was largely positive except for the NGX Consumer Goods which fell by 0.02%. The NGX Banking index, NGX Industrial Index, NGX Insurance Index and the NGX Oil/Gas index, increased by 0.52%, 0.13%, 0.36% and 1.10% respectively. Elsewhere, market activity was weak as the volume and the value of stocks traded today decreased further by 5.77% and 7.26% to 211.09 million shares and N 2.46 billion respectively. Elsewhere, NIBOR stays flat across tenor buckets tracked. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond rose for all maturities tracked amid renewed bullish sentiment.
