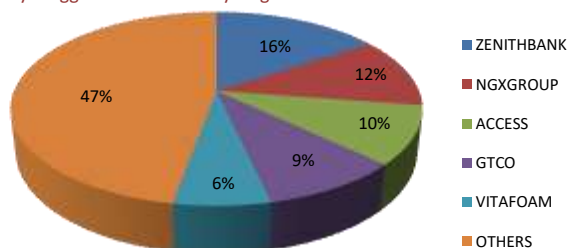

Local Bourse Index Rebounds by 0.08% amid Renewed Bullish Activity; NIBOR Moderates for Most Tenor Buckets on Financial System Liquidity Ease....

The Nigerian equities market All Share-Index rebounded by 0.08% to close at 42,262.85 points amid renewed bargain hunting activity. We saw buying interest in tickers such as UBN, PZ, WAPCO, TRANSCORP, and AIICO as their respective share prices increased by 9.90%, 7.20%, 3.23%, 2.06% and 1.43%. Consequently, the year-to-date gain of the local bourse bounced back to 4.95% albeit, the Exchange printed a higher number of losers (13) than gainers (12). Given the bullish sentiment, performance across sub-indices tracked was largely positive except for the NGX Oil/Gas which remained unchanged. The NGX Banking index, NGX Insurance Index, NGX Consumer Goods Index and the NGX Industrial index, increased by 0.73%, 0.24%, 0.13% and 1.19% respectively. Elsewhere, market activity was weak as the volume and the value of stocks traded today decreased further by 47.02% and 63.00% to 111.84 million shares and N 911.92 million respectively. Elsewhere, NIBOR moderates for most tenor buckets on financial system liquidity ease. However, NITTY fell for all maturities tracked amid bullish sentiment. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond rose for most maturities tracked amid sustained bullish sentiment.
