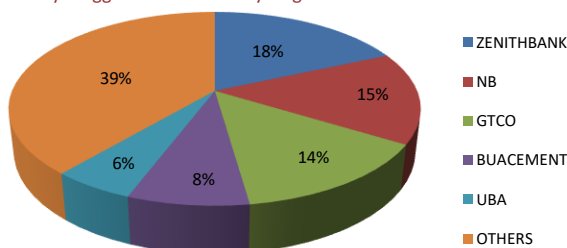

NGX All-Share Index Rises by 0.73% amid Gains on BUACEMENT, TRANSCORP, WEMABANK Shares; NIBOR Rises for Most Tenor Buckets amid Liquidity Strain...

The Local bourse Index rose by 0.73% with a gain of 0.73% year-to-date to close at 43,026.23 points, despite the Exchange printing a higher number of losers (27) than gainers (18). ACADEMY (+10.00%), WEMABANK (+9.72%), STANBIC (+5.56%), ETI (+2.30%), FLOURMILL (+2.29%), and TRANSCORP (+2.08%) closed positive while NNFM (-10.00%), ARDOVA (-10.00%), WAPIC (-5.36%) and UACN (-5.26%) closed negative. Given the higher number of losers, performance across sub-indices tracked were largely negative except for the NGX Banking index and the NGX Industrial index which rose by 0.39% and 2.97% respectively. The NGX Insurance, NGX Consumer Goods index and the NGX Oil/Gas Index, decreased by 0.43%, 0.92% and 0.50% respectively. Elsewhere, market activity was weak as the volume and the value of stocks traded today decreased by 52.41% and 84.67% to 216.651 million shares and N 1.52 billion respectively. Meanwhile, NIBOR rose for most maturities tracked on sustained liquidity strain. Also, NITTY rose for most maturities tracked on demand pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond fell for most maturities tracked amid sustained bearish sentiment.
