

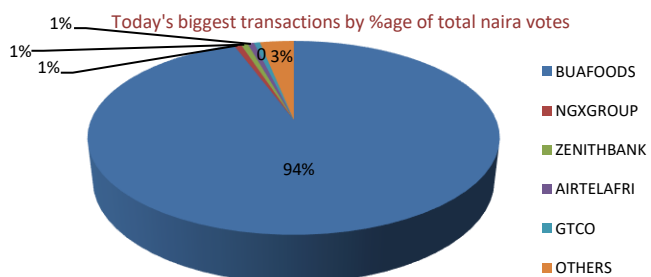


# Cowry Daily Market Insight 05 January 2022

NGX ASI Soars by 1.05% as BUAFOODS Stock Rises By 10.00%; NIBOR Falls for All Tenor Buckets amid Financial System Liquidity Ease...

The Local bourse Index rose by 1.05% with a gain of 1.78% year-to-date to close at 43,476.75 points, even as the Exchange printed a higher number of gainers (22) than losers (17). BUAFOODS gained 10.00% to lead the best five performing stocks in the session. Also, AIRTELAFRI (+10.00%), OANDO (+9.73%), AIICO (+8.33%), ARDOVA (+7.69%) and SEPLAT (+2.31%) closed positive while UNITYBNK (-9.62%), WAPIC (-3.77%), DANGCEM (-2.72%) and BUACEMENT (-2.71%) closed negative. Performance across sub-indices tracked were largely negative except for the NGX Insurance index and the NGX Oil/Gas index which rose by 0.85% and 3.12% respectively. The NGX Banking, NGX Consumer Goods Index and the NGX Industrial Index decreased by 0.50%, 0.02% and 2.42% respectively. Elsewhere, market activity was strong as the volume and the value of stocks traded today increased by 472.75% and 2734.78% to 1,240.86 million shares and N 42.97 billion respectively as BUAFOODS accounted for 94% of the total value traded today. Meanwhile, NIBOR fell for all tenor buckets tracked on renewed liquidity ease. Also, NITTY fell for most maturities tracked on demand pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond fell for most maturities tracked amid sustained bearish sentiment.
