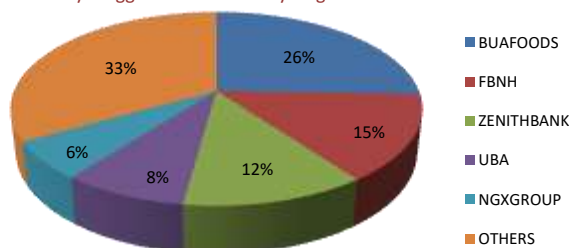

Local Bourse Index Rises by 0.30% amid Gains on BUAFOODS, MEYER, UACN Shares; NIBOR Moderates for All Tenor Buckets on Financial System Liquidity Ease....

The domestic stock market Index rose by 0.30% to close at 43,607.94 points amid sustained bargain hunting activities. Specifically, we saw buying interest in tickers such as BUAFOODS, MEYER, UACN, WAPCO, FCMB and FBNH as their respective share prices increased by 10.00%, 8.70%, 5.56%, 3.11%, 2.04% and 1.77%. Consequently, the year-to-date gain of the local bourse rose to 2.09%, even as the Exchange printed a higher number of gainers (24) than losers (13). Performance across sub-indices tracked was largely negative except for the NGX Banking index which increased by 0.44%. The NGX Oil/Gas index, NGX Insurance Index, NGX Consumer Goods Index and the NGX Industrial index, decreased by 0.90%, 1.35%, 0.12% and 0.39% respectively. Elsewhere, market activity was rather weak as the volume and the value of stocks traded today decreased by 85.93% and 95.04% to 174.611 million shares and N 2.13 billion. Meanwhile, NIBOR fell for all tenor buckets tracked on sustained financial liquidity ease. Meanwhile, NITTY rose for most maturities tracked amid renewed bearish sentiment. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond fell for most maturities tracked amid renewed bullish sentiment.
