

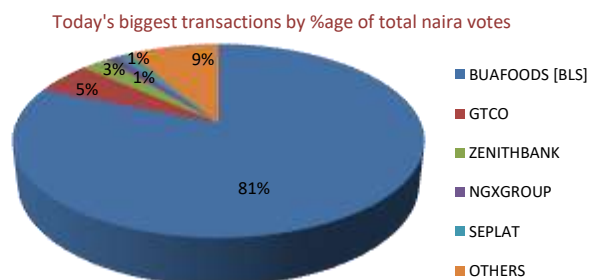

BUAFOODS Drives Local Bourse Rally as Index Rises Further by 0.57%; Overnight Rate Surges to 14.50% amid Renewed Liquidity Strain...

The Nigerian equities market Index further rose by 0.57% to close at 43,854.42 points as investors' appetite for BUAFOODS shares grew stronger – the company in the course of the week listed 18 billion shares on NGX. Other symbols such as CORNEST, MEYER, ARDOVA and PZ also enjoined investors' patronage today, hence lifting their respective share prices by 10.00%, 10.00%, 9.92% and 9.84% even as the Exchange recorded (31) gainers than losers (9). Consequently, the year-to-date gain of the local bourse rose to 2.66%. Similarly, performance across sub-indices tracked was positive as the NGX Banking index, NGX Insurance Index, NGX Consumer Goods Index, NGX Oil/Gas index and the NGX Industrial index rose by 0.44%, 0.01%, 0.19%, 0.98 and 0.26% respectively. Elsewhere, BUAFOODS chiefly contributed to market activity given the N10.06 billion of its shares that exchange hands today. Hence, the volume and the value of stocks traded ballooned by 126.31% and 481.35% to 395.15 million shares and N12.39 billion respectively. Meanwhile, NIBOR rose for all tenor buckets tracked on liquidity strain. Also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid renewed bullish sentiment.
