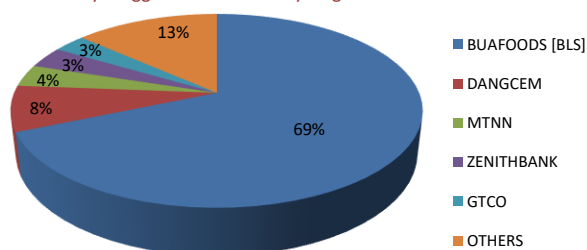

NGX ASI Soars by 0.10% amid Sustained Bargain Hunting on BUAFOODS Shares; NIBOR Falls for Most Tenor Buckets amid Financial System Liquidity Ease...

The Local bourse Index rose by 0.10% with a gain of 2.76% year-to-date to close at 43,897.13 points, even as the Exchange printed a higher number of gainers (27) than losers (22). BUAFOODS Shares continued its dominance, as it further gained by 9.96% to lead the best five performing stocks. Also, MRS (+9.72%), PZ (+8.53%), AIICO (+7.69%), DANGCEM (+4.00%) and VITAFOAM (+3.70%) closed positive while UBN (6.90%), MTNN (-5.84%), FLOURMILL (-3.10%) and OANDO (-2.95%) closed negative. Despite the northward movement in the benchmark index, Performance across sub-indices were largely negative, except for the NGX Insurance index and the NGX Industrial index which rose by 2.77% and 1.71% respectively. The NGX Banking index, NGX Consumer Goods Index and the NGX Oil/Gas index fell by 0.12%, 0.05% and 0.58% respectively. Elsewhere, Market was rather weak as the volume and the value of stocks traded today decreased by 21.23% and 30.30% to 311.26 million shares and N 8,64 billion respectively. Meanwhile, NIBOR fell for most tenor buckets tracked on liquidity ease. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid renewed bearish sentiment.
