

Local Bourse Index Rebounds by 1.71% amid Renewed Bullish Activity; NIBOR Moderates for All Tenor Buckets on Financial System Liquidity Ease....

The Nigerian equities market All Share-Index rebounded by 1.718% to close at 44,608.82 points amid renewed bargain hunting activity. We saw buying interest in tickers such as DANGCEM, TRANSCORP, SEPLAT, GUINESS, BUAFOODS, MTNN and PZ, as their respective share prices increased by 6.18%, 5.10%, 2.99%, 2.93%, 2.56%, 2.15% and 2.14%. Consequently, the year-to-date gain of the local bourse bounced back to 4.43% even as the Exchange printed a higher number of gainers (24) than losers (15). Given the bullish sentiment, performance across sub-indices tracked was largely positive, except for the NGX Insurance Index which fell by 0.49%. The NGX Banking Index, NGX Consumer Goods Index, NGX Oil/Gas index and the NGX Industrial Index rose by 0.39%, 0.14%, 1.37% and 3.06% respectively. Elsewhere, Market came in weak as the volume and the value of stocks traded decreased by 9.58% and 43.53% to 266.23 million shares and N 3.82 billion respectively. Meanwhile, NIBOR moderates for most tenor buckets on financial system liquidity ease. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained bearish sentiment.
