

Nigerian Stock Market Index Falls Marginally by 0.01% amid Losses on UACN, HONEYFLOUR, WAPIC Shares; NIBOR Moves in Mixed Directions...

The Local bourse Index fell marginally by 0.01% albeit with a gain of 4.42% year-to-date to close at 44,604.74 points, even as the Exchange printed a higher number of losers (15) than gainers (14). TRANSCORP (+9.71%), JAIZBANK (+6.06%), INTERBREW (+4.04%), COURTVILLE (+2.78%) and AIICO (+2.56%)) closed positive while NEM (-10.00%), UACN (-8.70%), HONEYFLOUR (-2.35%), WAPIC (-2.04%) and UNILEVER (-1.49%) closed negative. Performance across sub-indices was mixed bag as the NGX Insurance Index fell by 0.93% while the NGX Banking Index and NGX Consumer Goods Index rose by 0.07% and 0.16%. respectively The NGX Oil/Gas index and the NGX Industrial Index remained unchanged. Meanwhile, Market activity moved in mixed directions as the volume of stocks traded today increased by 20.81% to 321.75 million shares, while the value of stocks traded decreased by 4.37% to N 3.66 billion. Elsewhere, NIBOR and NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained bearish sentiment.
