

Local Bourse Stock Index Falls by 0.34% amid Renewed Profit Taking Activity; NIBOR Rises for Most Maturities Tracked amid Financial System Liquidity Squeeze ...

The Nigerian stock market All Share-Index fell by 0.34% to close at 44,454.67 points amid renewed profit taking activity. Also, the Exchange printed a higher number of losers (17) than gainers (14) as CUTIX (-7.17%), JAIZBANK (-2.86%), UNITYBNK (-2.00%), DANGCEM (-1.82%) and AIICO (-1.25%) closed negative while JBERGER (+3.64%), STERLINGBANK (+3.29%), UCAP (+1.80%), HONEYFLOUR (+1.20%), NB (+1.10) and TRANSCORP (+0.88%) closed positive. Performance across sub-indices was mixed bag as the NGX Insurance Index and the NGX Industrial Index fell by 0.69% and 0.94% respectively while the NGX Banking Index and NGX Consumer Goods Index rose by 0.26% and 0.18% respectively. The NGX Oil/Gas index remained unchanged. Meanwhile, market activity was strong as the volume and the value of stocks traded today increased by 26.10% and 168.88% to 405.74 million and N9.83 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked on renewed financial liquidity squeeze. Also, NITTY rose for most maturities tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained bearish sentiment.
