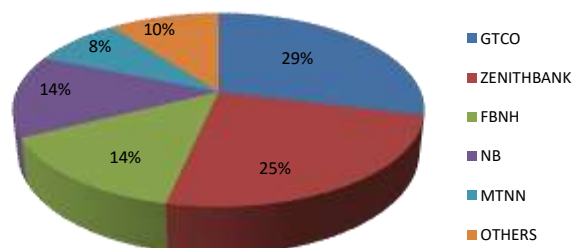

**Nigerian Stock Market Index Further Dips by 0.12% amid Losses on BUAFOODS, PZ Shares; NIBOR Moderates for Most Maturities on Financial System Liquidity Ease...**

The Local bourse Index further fell by 0.12% to close at 44,399.66 points amid profit taking activity. Also, the Exchange printed a higher number of losers (22) than gainers (16) amid sustained profit taking activity. Consequently, the year-to-date gain of the local bourse fell to 3.94%. BUAFOODS (-6.36%), COURTVILLE (-5.41%), TRANSCORP (-5.26%) and PZ (-2.10%) closed negative; while TIP (+10.00%), WAPIC (+6.25%), NB (+2.83%) and BUACEMENT (+2.19%) closed positive. Performance across sub-indices was largely positive, except for the NGX Banking Index and the NGX Insurance Index which fell by 0.08% and 0.19% respectively. The NGX Consumer Goods Index, NGX Oil/Gas Index and the NGX Industrial Index rose by 0.20%, 0.21% and 0.81% respectively. Meanwhile, market activity was weak as the volume and the value of stocks traded today decreased by 47.18% and 72.64% to 214.32 million and N2.69 billion respectively. Elsewhere, NIBOR fell for most tenor buckets tracked on renewed financial liquidity ease. Meanwhile, NITTY rose for most maturities tracked on negative sentiment. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained bearish sentiment.
