

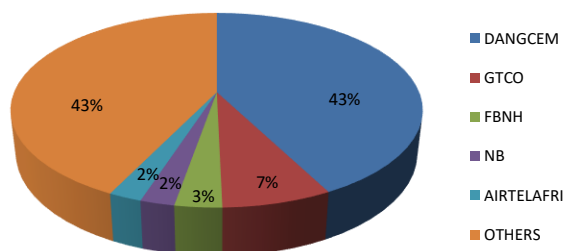


# Cowry Daily Market Insight 19 January 2022

NGX All-Share Index Soars by 1.76% as AIRTELAFRI Share Rises by 10.00% NIBOR Moderates for All Maturities Tracked on Financial Liquidity Ease...

The Local bourse Index rose by 1.76% with a gain of 6.35% year-to-date to close at 45,430.14 points, despite the Exchange printing a higher number of losers (18) than gainers (17). AIRTELAFRI gained 10.00% to lead the best five performing stocks in the session. Also, COURTVILLE (+5.26%), SEPLAT (+4.36%), NEM (+1.93%), and ZENITHBANK (+0.19%) closed positive while JAIZBANK (-4.55%), TRANSCORP (-2.83%), DANGCEM (-1.85%) and HONEYFLOUR (-0.59%) closed negative. Performance across sub-indices was largely positive except for the NGX Consumer Goods Index which fell by 0.02%. The NGX Banking Index, NGX Insurance Index and the NGX Oil/Gas index rose by 0.50%, 0.59% and 2.21% respectively, while the NGX Industrial Index remained unchanged. Meanwhile, market activity was strong as the volume and the value of stocks traded today increased by 7.53% and 365.28% to 252.94 million shares and N 8.93 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid financial system liquidity ease. Meanwhile, NITTY rose for most maturities tracked on sustained sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bearish sentiment.
