

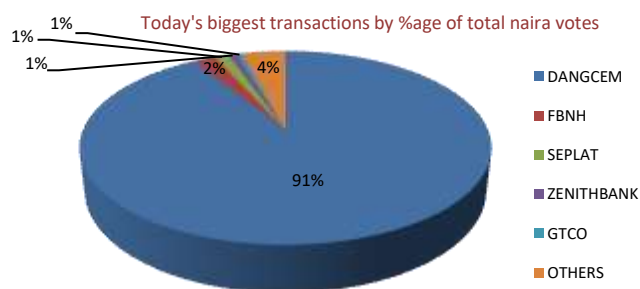

The NGX All-Share Index Soars by 1.01% as DANGCEM Completes Share Buy-Back Programme; NIBOR Rises for Most Maturities on Financial Liquidity Squeeze...

The Local bourse Index soared by 1.01% to close at 45,890.52 points amid sustained bargain hunting activity. Also, the Exchange printed 27 gainers as against 9 losers, indicating a robust positive sentiment. Hence, the year-to-date gain of the local bourse rose to 7.43%. Notably, CADBURY, JAIZBANK, UNITYBNK, DANGCEM and COURTVILLE were the toast of investors today as their respective share prices rose by 7.95%, 6.35%, 6.25%, 5.52% and 5.00%. Performance across sub-indices was positive except for the NGX Consumer Goods Index and the NGX Oil/Gas index which fell by 0.17% and 0.09% respectively. The NGX Banking Index, NGX Insurance Index and the NGX Industrial Index rose by 0.36%, 0.52% and 2.72% respectively. Meanwhile, market activity came in strong chiefly on N28.78 billion worth of DANGCEM shares that exchanged hands today even as it completed its share buy-back scheme today. Hence, the volume and value of stocks traded rocketed by 245.34% and 253.41% to 873.49 million shares and N 31.54 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid financial system liquidity squeeze. Meanwhile, NITTY fell for most maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bullish sentiment.
