

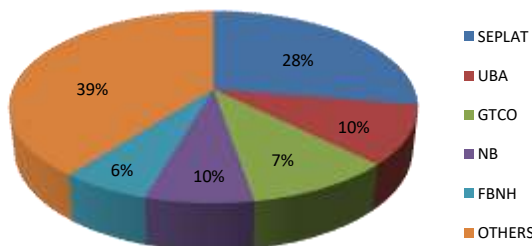

Nigerian Stock Market Index Dips by 0.06% amid Renewed Profit Taking Activity; NIBOR Rises for Most Maturities on Financial System Liquidity Squeeze...

The Local bourse Index dipped by 0.06% to close at 45,928.27 points amid profit taking activity. Also, the Exchange printed a higher number of losers (26) than gainers (15) as more penny stocks lost value today. Consequently, the year-to-date gain of the local bourse fell to 7.52%. Specifically, REGALINS (-9.52%), NEM (-5.41%), AIICO (-2.44%) and FBNH (-1.67%) closed negative; while COURTVILLE (+8.70%) – amid sustained strong buying interest, SEPLAT (+3.30%), HONEYFLOUR (+1.56%) and GUINNESS (+0.71%) closed positive. Performance across sub-indices was largely negative except for the NGX Oil/ Gas which rose by 1.67%. The NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index and the NGX Industrial index plunged by 0.45%, 1.44%, 0.23% and 0.01% respectively. Meanwhile, Market activity was mixed, as the volume of stocks traded today decreased by 1.06% to 278.61 million shares while the value of stocks traded rose by 19.71% to N 2.89 billion. Elsewhere, NIBOR rose for most tenor buckets on financial system liquidity squeeze. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained flattish. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bearish sentiment.
