

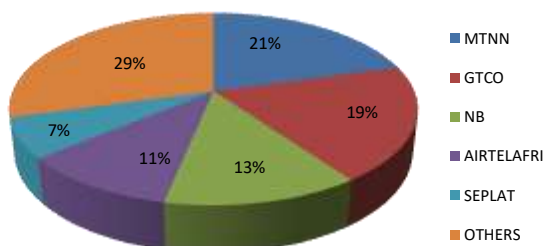

NGX-ASI Surges by 0.02% amid Gains on AIRTELAFRI, ETI, COURTVILLE Shares; NIBOR Rises for Most Maturities on Financial System Liquidity Strain....

The NGX All Share-Index surged by 1.29% to close at 46,529.99 points despite the Exchange printing the same number of gainers and losers (19). AIRTELAFRI notched 10.00% gain to lead the best five performing stocks in the session. Also, we saw buying interest in Tickers such as ETI, COURTVILLE - amid 3-day winning streak -, HONEYFLOUR, JBERGER, UCAP and FCMB, which lead to 9.55%, 9.09%, 3.03%, 2.63%, 2.33% and 1.33% increase in their respective share prices. Performance across sub-indices was negative except for the NGX Banking Index which rose by 1.32%. The NGX Insurance, NGX Consumer Goods Index, NGX Oil/ Gas Index and the NGX Industrial Index fell by 0.63%, 0.39%, 0.59% and 0.89% respectively. Meanwhile, Market activity was strong today, as the volume and value of stocks traded mushroomed by 32.82% and 34.66% to roughly 329.00 million shares and N 4.82 billion respectively. Elsewhere, NIBOR rose for most tenor buckets on financial system liquidity strain. Also, NITTY rose for most maturities tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds rose for most maturities tracked amid sustained buy pressure. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid renewed bullish sentiment.
