

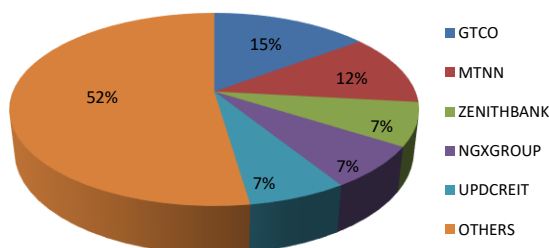

Nigerian Equities Market Index Falls by 1.12% amid Losses on DANGCEM, AIICO Shares; NIBOR Falls for Most Maturities on Financial System Liquidity Ease....

The Local bourse Index fell by 1.12% to close at 46,009.23 points, despite the Exchange printing a higher number of gainers (25) than losers (24). Consequently, the year-to-date gain of the local bourse fell to 7.71%. DANGCEM (-8.53%), AIICO (-5.00%), ARDOVA (-4.96%), JAIZBANK (-4.29%) and FBNH (-1.30%) closed negative; while GUINNESS (+10.00%), ETI (+9.63%), UNILEVER (+7.28%), TRANSCORP (+3.77%) and BUACEMENT (+2.87%) closed positive. Given the bearish sentiment, performance across sub-indices came in negative except for the NGX Banking Index and the NGX Consumer Goods Index which rose by 1.08% and 1.77%. The NGX Insurance Index, NGX Oil/ Gas Index and the NGX Industrial Index fell by 1.79%, 0.48%, and 3.75% respectively. Meanwhile, Market activity was weak today, as the volume and value of stocks traded decreased by 15.06% and 42.64% to 279.44 million shares and N 2.76 billion respectively. Elsewhere, NIBOR fell for most tenor buckets on sustained financial system liquidity ease. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds moved in mixed directions across maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bear sentiment.
