

NGX All-Share Index Rises by 0.43% amid Gains on ETI, TOTAL, FBNH Shares; NIBOR stays Flat across Most Tenor Buckets....

The domestic stock market index rose by 0.43 % with a gain of 8.17% year-to-date to close at 46,205.05 points, even as the Exchange printed higher number of gainers (39) than losers (7). Notably, CORNERST gained 10.00% to lead the best five performing stocks at close of trading today. Also, ETI (+9.62%), TOTAL (+8.61%), FBNH (+4.82%), JBERGER (+4.35%) and GUINNESS (+2.89%) closed positive while UPL (-9.86%), CHIPLC (-7.69%), CUTIX (-4.00%), ETERNA (-1.48%) and CADBURY (-1.14%) closed negative. Given the bullish sentiment, performance across sub-indices came in positive except for the NGX Industrial Index which fell by 0.01%. The NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas Index rose by 2.30%, 1.61%, 0.81% and 2.22% respectively. Meanwhile, Market activity was strong today, as the volume and value of stocks traded increased by 12.17% and 82.20% to 313.45 million shares and N 5.03 billion respectively. Elsewhere, NIBOR was flattish for most tenor buckets tracked. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were flattish across most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained bearish sentiment.
