Local Bourse Index Increases by 0.91% amid Gains on GTCO, MTNN, PRESCO Shares; NIBOR Falls for All Tenor Buckets on Financial Liquidity Ease...

The local bourse index rose by 0.91% to close at 46,624.67 points amid bargain hunting on shares of PRESCO, GTCO, MTNN, TRANSCORP and ZENITHBANK. Hence, their respective share prices increased by 9.97%, 4.87%, 3.95%, 2.70% and 1.17%. Consequently, the year-to-date gain of the local bourse rose by 9.15% even as the Exchange printed a higher number of gainers (33) than losers (23). Given the northward movement in the benchmark index, performance across sub-indices came in positive except for the NGX Insurance Index and NGX Consumer Goods Index which fell by 0.20% and 0.23% respectively. The NGX Banking Index, NGX Oil/ Gas Index and NGX Industrial Index rose by 0.43%, 0.32% and 0.47% respectively. Meanwhile, market transaction was mixed as the volume of stocks traded today increased by 39.03% to N435.70 million while the value of stocks traded fell by 31.65% to N 3.44 billion. Elsewhere, NIBOR fell for all maturities tracked on renewed financial liquidity ease. However, NITTY rose for most maturities tracked on renewed sell pressure, especially at the shorter end of the curve. In the OTC bonds market, the values of the FGN bonds depreciated across most maturities tracked amid renewed bearish sentiment. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid renewed buy pressure.
