


NGX ASI Increases by 1.04% amid Bargain Hunting on SEPLAT, CONOIL, PRESCO Shares; NIBOR Rises for Most Tenor Buckets on Financial Liquidity Strain... The NGX All Share-index rose by 1.04% to close at 47,111.21 points amid bargain hunting on shares of SEPLAT, CONOIL, PRESCO, WAPCO, ZENITHBANK and GTCO. Hence, their respective share prices increased by 10.00%, 9.79%, 8.75%, 5.47%, 4.99% and 4.09%. Consequently, the year-to-date gain of the local bourse rose by 10.29% even as the Exchange printed a higher number of gainers (36) than losers (21). Given the northward movement in the benchmark index, performance across sub-indices came in positive except for the NGX Consumer Goods Index which fell by 0.05%. The NGX Banking Index, NGX Insurance Index, NGX Oil/ Gas Index and NGX Industrial Index rose by 2.59%, 0.64%, 5.77% and 0.85% respectively. Meanwhile, market transaction was mixed as the volume of stocks traded today increased by 8.96% to N341.52 million while the value of stocks traded fell by 26.66% to N 3.69 billion. Elsewhere, NIBOR rose for most maturities tracked on renewed financial liquidity strain. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy pressure.
