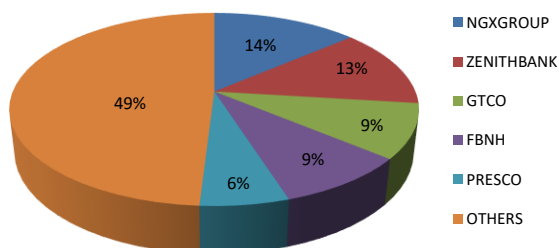


## NGX All-Share Index Falls by 0.38% amid Renewed Profit Taking Activity; NIBOR Moderates for All Tenor Buckets amid Financial System Liquidity Ease...

The domestic stock market index fell by 0.38% to close at 46,930.68 as the bears finally took over the Exchange. Hence, the year-to-date gain of the local bourse fell to 9.87% even as, the Exchange printing a higher number of losers (33) than gainers (22). Specifically, the share prices of COURTVILLE, ZENITHBANK, TRANSCORP, WAPCO, UNILEVER, MTNN, GTCO and NB declined by 6.90%, 3.11%, 2.56%, 2.22%, 1.79%, 1.23%, 1.07% and 0.93% respectively. Given the southward movement in the benchmark index, performance across sub-indices came in negative except for the NGX Oil/ Gas Index which rose by 0.62%. The NGX Banking Index, NGX Insurance Index and NGX Industrial Index fell by 1.39%, 1.85% and 0.17% respectively. The NGX Consumer Goods Index remained unchanged. Meanwhile, market activity was strong today, as the volume of stock traded rose by 27.36% to N434.95 million; also, the value of stocks traded increased by 69.55% to N6.26 billion – as investors sold more of Blue-Chip stocks. Elsewhere, NIBOR moderated for most maturities tracked on renewed financial liquidity ease. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy pressure.
