

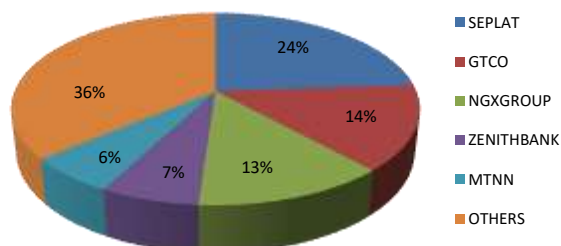


# Cowry Daily Market Insight 04 February 2022

**Nigerian Equities Market Index Falls by 0.11% amid Losses on PRESCO, NEM, FBNH Shares; NIBOR Rises for All Maturities on Financial System Liquidity Strain....**

The Local bourse Index fell by 0.11% to close at 47,279.92 points, even as the Exchange printed a higher number of losers (25) than gainers (18). Consequently, the year-to-date gain of the local bourse fell to 10.68%. Specifically, PRESCO (-10.00%), NEM (-9.76%), FBNH (-2.63%), FLOURMILL (-0.85%) and SEPLAT (-0.24%) closed negative; while JAIZBANK (+5.97%), DANGSUGAR (+0.29%), WAPCO (+0.19%), GTCO (+0.18%) and MTNN (+0.15%) closed positive. Given the southward movement in the benchmark index, performance across sub-indices came in negative except for the NGX Banking Index and the NGX Industrial Index which rose by 0.18% and 0.01% respectively. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas Index fell by 0.90%, 0.58% and 0.24% respectively. Meanwhile, market activity was weak today as the volume of stock traded fell by 34.91% to N225.69 million; also, the value of stocks traded decreased by 37.78% to N2.39 billion. Elsewhere, NIBOR rose for all maturities tracked on financial system liquidity strain. Meanwhile, NITTY moved in mixed directions ahead of next week auction. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
