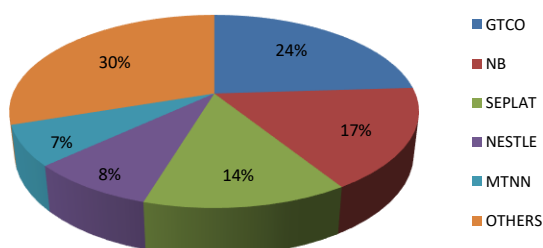


Local Bourse Index Falls by 0.16% amid Losses on AIICO, GTCO, SEPLAT Shares; NIBOR Moderates for Most Maturities on Financial System Liquidity Ease....

The domestic stock market Index fell by 0.16% to close at 47,203.39 points despite the Exchange printing the same number of gainers and losers (23). Consequently, the year-to-date gain of the local bourse fell to 10.50%. Specifically, OKOMUOIL (-10.00%), OANDO (-7.95%), PZ (-7.19%), GTCO (-0.55%) and SEPLAT (-0.46%) closed negative; while SUNUASSUR (+10.00%), COURTVILLE (+3.77%), UPL (+3.60%), ZENITHBANK (+2.28%) and UBA (+1.17%) closed positive. Given the southward movement in the benchmark index, performance across sub-indices came in negative except for the NGX Banking Index which rose by 1.14%. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas Index fell by 0.84, 0.43% and 1.48% respectively. The NGX Industrial Index remained unchanged. Meanwhile, market activity was strong today as the volume of stock traded rose by 26.49% to N285.48 million; the value of stocks traded increased by 115.02% to N5.13 billion. Elsewhere, NIBOR fell for most maturities tracked on financial system liquidity ease. However, NITTY rose for most maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
