NGX All-Share Index Falls further by 0.31% amid Sustained Sell-Pressure; NIBOR Falls for All Tenor Buckets amid Financial System Liquidity Ease...

The domestic stock market index fell by 0.31% to close at 47,203.39 points. Hence, the year-to-date gain of the local bourse moderated to 10.16%. Also, the Exchange printed a higher number of losers (21) than gainers (18). Specifically, the share prices of COURTVILLE, UNILEVER, BUAFOODS, MTNN and GTCO declined by 7.72%, 4.36%, 4.04%, 1.01% and 0.37% respectively. Despite the southward movement in the benchmark index, performance across sub-indices was largely positive except for the NGX Banking Index and the NGX Industrial Index which fell by 0.17% and 0.01% respectively. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas Index rose by 2.35, 0.04% and 0.89% respectively. Meanwhile, market activity was weak today as the volume of stock traded fell by 16.56% to N238.22 million; also, the value of stocks traded decreased by 0.87% to N5.09 billion. Elsewhere, NIBOR fell for all maturities tracked on financial system liquidity ease. Also, NITTY fell for most maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish for all maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
