

Local Bourse Index Falls by 0.29% amid Losses on HONEYFLOUR, AIRTELAFRI, GTCO Shares; NIBOR Moderates for Most Maturities on Financial System Liquidity Ease....

The domestic stock market Index fell by 0.29% to close at 47,063.28 points despite the Exchange printing the same number of gainers and losers (23). Consequently, the year-to-date gain of the local bourse fell to 10.18%. Specifically, COURTVILLE (-7.27%), HONEYFLOUR (-4.29%), AIRTELAFRI (-1.65%), WAPCO (-0.93%) and GTCO (-0.75%) closed negative; while GUINNESS (+10.00%), UNILEVER (+6.08%), FLOURMILL (+3.56%), ZENITHBANK (+0.56%) and MTNN (+0.25%) closed positive. Given the southward movement in the benchmark index, performance across sub-indices was largely negative except for the NGX Banking Index and the NGX Consumer Goods Index which rose by 0.04% and 1.06% respectively. The NGX Insurance Index, NGX Oil/ Gas Index and the NGX Industrial Index fell by 0.16%, 0.24%, and 0.07% respectively. Meanwhile, market activity was rather strong today as the volume of stock traded rose by 8.51% to N338.03 million; also, the value of stocks traded increased by 29.41% to N5.68 billion – as investors sold more of blue-chip stocks. Elsewhere, NIBOR fell for most tenor buckets tracked on liquidity boost. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were mixed for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
