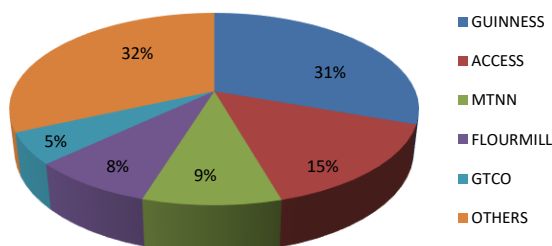


## Nigerian Stock Market Index Stays Flat at 47,064.82 Points; NITTY Rose for Most Maturities Tracked amid Sell Pressure...

The Local bourse Index remained unchanged with a gain of 10.18% year-to-date to close at 47,064.82 points, despite the Exchange printing a higher number of gainers (28) than losers (21). NEM (+8.36%), FCMB (+5.03%), FLOURMILL (+4.93%), FLOURMILL (+1.55%), CADBURY (+2.31%) and FBNH (+1.79%) closed positive while BERGER (-9.58%), JAIZBANK (-4.29%), INTERBREW (-2.86%), ETI (-2.80%), GUINNESS (-2.33%) and ACCESS (-0.48%) closed negative. Performance across sub-indices was largely positive except for the NGX Banking Index and the NGX Industrial Index which fell by 1.01% and 0.02% respectively. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas Index rose by 1.51%, 0.10%, and 0.26% respectively. Meanwhile, market activity was rather weak today as the volume of stock traded fell by 18.88% to 274.21 million; also, the value of stocks traded decreased by 32.74% to N3.82 billion – even as investors took profit on GUINNESS shares. Elsewhere, NIBOR moved in mixed directions. However, NITTY rose for most tenor buckets tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds appreciated for most maturities tracked amid bullish sentiment. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
