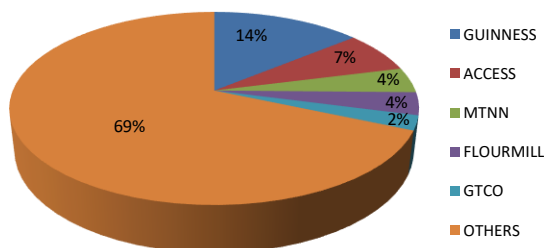


Nigerian Stock Market Index Rises by 0.09% amid Gains on UACN, COURTVILLE Shares; NITTY Falls for Most Maturities Tracked amid Buy Pressure...

The Local bourse Index rose by 0.09% with a gain of 10.28% year-to-date to close at 47,109.25 points, despite the Exchange printing a higher number of losers (29) than gainers (19). UACN (+6.52%), COURTVILLE (+5.88%), AIRTELAFRI (+0.80%) and MTNN (+0.50%) closed positive while UPDC (-6.36%), HONEYFLOUR (-2.06%), WAPCO (-1.52%) and GTCO (-1.14%) closed negative. Performance across sub-indices was largely negative as all the five sector-gauges tracked fell. The NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index, NGX Oil/ Gas Index and the NGX Industrial Index fell by 0.20%, 0.04%, 0.09%, 0.04%, and 0.34% respectively. Meanwhile, market activity was rather strong today as the volume of stock traded rose by 16.07% to 318.27 million; also, the value of stocks traded increased by 116.55% to N8.27 billion. Elsewhere, NIBOR was flattish for most maturities tracked. However, NITTY fell for most tenor buckets tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds appreciated for most maturities tracked amid sustained bullish sentiment. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid renewed buy pressure.
