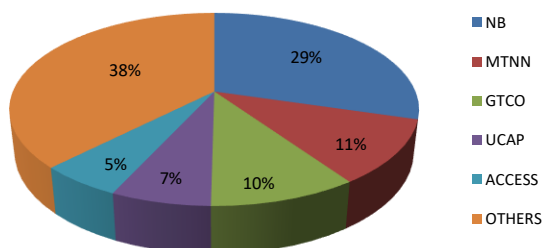


Local Bourse Index Rose by 0.20% amid Gains on UCAP, GUINNESS, TRANSCORP, PZ Shares; NITTY Rose for All Tenor Buckets on Sell Pressure...

The local bourse index rose by 0.20% to close at 47,233.91 points amid bargain hunting on shares of UCAP, MAYBAKER, INTERBREW, GUINNESS, INTBREW, TRANSCORP, WAPIC and PZ. Hence, their respective share prices increased by 10.00, 8.31%, 6.67%, 5.71%, 4.27%, 4.17% and 2.94%. Consequently, the year-to-date gain of the local bourse rose to 10.58% even as the Exchange printed a higher number of gainers (31) than losers (17). Performance across sub-indices was largely positive as four of the five sub sector gauges rose. The NGX Banking Index, NGX Consumer Goods Index, NGX Insurance Index and the NGX Industrial Index rose by 0.66%, 0.22%, 0.37% and 0.01% respectively. The NGX Oil/ Gas Index remained unchanged. Meanwhile, market activity was weak today as the volume of stock traded fell by 0.76% to 421.46 million; also the value of stocks traded decreased by 35.30% to N4.22 billion. Elsewhere, NIBOR fell for most maturities tracked on financial system liquidity ease. However, NITTY rose for all tenor buckets tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
