




Cowry Daily Market Insight 22 February 2022

NGX-ASI Rises by 0.03% amid Gains on MAYBAKER, TRANSCORP, UCAP, GTCO Shares; NITTY Falls for Most Tenor Buckets on Buy Pressure...

The NGX All Share-Index rose by 0.03% to close at 47,246.90 points even as the Exchange printed a higher number of gainers (29) than losers (18). LEARNAFRCA gained 10.00% to lead the best five performing stocks in the session; Also, we saw buying interest in Tickers such as MAYBAKER, BERGER, TRANSCORP, UCAP, GTCO and HONEYFLOUR, leading to 9.65%, 9.27%, 2.46%, 2.27%, 1.32% and 1.30% increase in their respective share prices. Performance across sub-indices was largely negative, as three of the five sub sector gauges fell. The NGX Banking Index, NGX Insurance Index and the NGX Consumer Goods Index fell by 0.08%, 0.61% and 0.40% respectively, while the NGX Oil/ Gas Index and the NGX Industrial Index rose marginally by 0.01% and 0.02% respectively. Meanwhile, market activity was strong today as the volume of stock traded rose by 0.09% to 421.82 million; also, the value of stocks traded increased by 22.14% to N5.16 billion. Elsewhere, NIBOR fell for most maturities tracked on financial system liquidity ease. Also, NITTY fell for most tenor buckets tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
