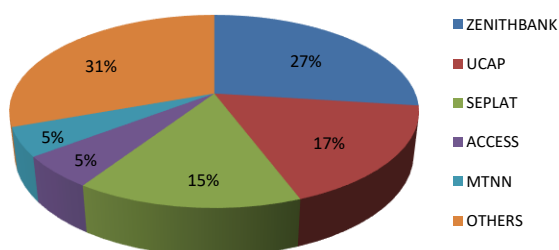


NGX All-Share Index Falls further by 0.08% amid Sustained Sell-Pressure; NIBOR Rises for Most Tenor Buckets amid Financial System Liquidity Squeeze...

The domestic stock market index fell by 0.08% to close at 47,207.27 as the exchange printed a higher number of losers (26) than gainers (16). Hence, the year-to-date gain of the local bourse fell to 10.51%. Specifically, the share prices of DANGSUGAR, ETI, UNITYBNK, INTERBREW and FLOURMILL declined by 5.28 %, 2.98%, 2.00%, 1.79% and 1.49% respectively. Performance across sub-indices was largely negative, as three of the five sub sector gauges fell. The NGX Banking Index, NGX Consumer Goods Index and the NGX Industrial Index fell by 0.35%, 0.58% and 0.02% respectively, while the NGX Insurance Index and the NGX Oil/ Gas Index rose by 0.91% and 0.03% respectively. Meanwhile, market activity was negative today as the volume of stock traded fell by 45.32% to 230.65 million; also, the value of stocks traded decreased by 32.24% to N3.49 billion. Elsewhere, NIBOR rose for most tenor buckets tracked on financial system liquidity squeeze. Also, NITTY fell for all tenor buckets tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
